Councillor Coren updated on recent problems with broadband. The licence application by Lower Eggbeer had been approved. Recycling rates were now over 50%. He has been informed there is somebody in residence in Venbridge Grange and would pass it on to the Enforcement Officer. The Young Farmers Club had invited the community to visit their new premises on the 26th November Councillor Heal reported planning has been very busy. M.D.D.C. would be taking part in the Syrian refuge scheme it would only be using private sector rented housing

Councillor Way was working with other agencies to support vulnerable people through the winter D.C.C. had arranged four meetings around the county to consult on tough choices. The road warden scheme is now working in some parishes, chapter 8 training is required and it's a 2 day course
